## Erasmus+ When the Family discovers that one of its members is addicted; THEIR FIRST REACTIONS






- Mothers an fathers do not want to face up to the case,
- Can not comprehend that the case is a problem,
- Can not ascribe the addiction to their children,
- They deny the case.

- An intensive feeling of guilt,
- Guilt feelings,
- Social isolation,





### When the Family discovers that one of its members is addicted ...



#### **DECISIONS TAKEN BY THE FAMILY**

#### **First Decision:**

- No one around should learn what is happening.
- No one outside the family and home should be interviewed.
- This case must not be known except for the family.



#### When the Family discovers that one of its members is addicted





#### Second decision:

- Utopic decisions and opinions develop:
- They think that they will solve the problem in short time, and
- Addicted person will get back to normal life if they give strong support.
- In this process;
- For the family, many physical and mental burdens develop,
- Family apply for treatment.










#### WHY DOES FAMILY DENY ADDICTION?





#### Why do families deny addiction?



#### Isolation:

- Families abstain from talking about addicted members in the society.
- Embarrassment encircle the atmosphere of the family members like a wall and drive them into silence.





#### Why do families deny addiction?

#### Emotional disorder:




- They go into the mood of the addicted person.
- They love what the addict love,
- bridle at the person whom addict bridle,
- feel embarrassed for the behaviours of the addict,
- get angry at their desperateness,
- ❖ Rarely share emotions and the thought between themselves,
- Give away to despair and anger instead of sharing,
- **❖ Family members sentence themselves to loneliness and depression.**





#### Why do families deny addiction?



#### Addict centeredness:

- Addict is the centre of family's attention.
- Family is in excited state continuously.
- They try to estimate what is unpredictable.
- They do not want the worsening things become much worse.
- There is stress over family members.
- Family denies addiction just as the addict does.










#### What Do Mothers and Fathers live through

## Actions to be taken by mothers and fathers



1-Go easy and calm down, it will be appropriate,

- To be calm,
- To think over,
- Then, get into action.





Actions to be taken by mothers and fathers



2-Do not blame yourselves.

Beating up yourself may turn into the rage against yourself and your child.





## Actions to be taken by mothers and fathers



## 3-Do not abstain from talking.

- Do not abstain from talking
- Make clear that you do not abstain talking.

#### 4-Do not frighten

- If the child is frightened during the discussion, he/she might be compelled to lie.
- May think that she/he is not understood.
- A conception may develop that she/he is right in using the substance.
- Being under pressure, may lead him/her to turn toward drug.





#### Actions to be taken by mothers and fathers gerekenler



## 5- Accept that she/he is different

- His/her behaviours may be different.
- May reveal different reactions.
- They lament that they've never seen such a child around them.



#### Actions to be taken by mothers and fathers gerekenler



#### 6-Control your feelings

- To think that no one is at fault,
- To confess that the problem lies in the relationship between the child and you,
- To think that she/she starts all over again,

Mean that desperation has been cast aside.



#### Actions to be taken by mothers and fathers gerekenler

#### 7- Draw the limits



#### Addicted individuals finds it difficult to:

- To draw the limits
- To obey the rules

#### Families should;

- Develop new strategies,
- Draw limits for their children and
- Make them to obey the rules.





#### Actions to be taken by mothers and fathers gerekenler

## 8-Have them to take the responsibility


- Teach the child to take his/her own responsibilities,
- Encourage them to take responsibilities of their lives,
- Do not take their responsibilities.

### 9- Pull your expectations down

- At first, accept that he/she is different,
- Set out to diminish his/her suffering,
- Do not think to make him/her a totally different child.

#### 10-Acquire new skills

As mothers and fathers, do acquire new skills,

For instance, the skills of;

- Rage management,
- Conflict and
- Problem solving.

#### 11-Develop new strategies

- Accept that the methods you have practised are ineffective,
- Do not practice ineffective methods again,
- Develop new and separate methods for different problem areas,

#### Actions to be taken by mothers and fathers



## 12- Be the first to take the step Do not forget that,

- Mother-father are to be changed first, and
- Are required to show a "generosity".





#### Actions to be taken by mothers and fathers




13- Improve quality of the communication between your child

Learn to acquire,

- The skill of effective listening, and
- To establish effective communication.

#### Actions to be taken by mothers and fathers



#### 14-Pursue your life

- Do not focus on addicted child.
- Pay attention to pursue your life.
- Protect other children at home, and
- Try to prevent them to be influenced by substance addict brothers/sisters.
- As being the mother and father, protect yourselves, and
- Deal with your substance addict child and spend a long time with him/her.

#### Actions to be taken by mothers and fathers



#### 15-Resolve the conflicts

- Abstain from the debate when the child is angry
- Speak about the problems with the child when she/he is calm and if everything is ok
- Do not debate when influenced by the substance
- Do not try to resolve the conflicts through debate or quarrel.

#### Actions to be taken by mothers and fathers



#### 16-Try to understand him/her

- Try to understand him and the things what he does,
- Comprehend that his trues might be different than our trues,
- Accept that he does not perform some behaviours intentionally,
- Not forget that, the things to be criticised are his behaviours, not his very self.

#### Actions to be taken by mothers and fathers




#### 17-Support him/her

- Remember that there are right things he has made,
- Do not focus all the time on his rights or wrongs,
- Appreciate his positive behaviours,
- Reward him for his positive behaviours,
- Concentrate on his good behaviours instead of his bad behaviours.



### **Actions to be taken by mothers and fathers**





### 18-Forget the past, focus on the future.

Forget the conflicts experienced before,

If the individual quitted using the drugs;

- Do not treat him constantly as a criminal
- Not judge him as a potential danger,
- Not accuse him by raking up the past days frequently



#### Actions to be taken by mothers and fathers



## 19-Do not frustrate in the event of the reversions.

- Accept that addiction is an sickness,
- Consider that exacerbation of the sickness is normal,





# Actions to be taken by mothers and fathers




# 20-Do not give credence to threatens to use drugs again.

- To begin using drugs again is up to his responsibility.
- Yet, he should learn to bear the consequences.

# 21- Do not expect him/her to change in every field.

- Care only about his quit of substance addiction.
- Postpone your other expectations.
